### Terms of Payment

CNS Driver Training Center of PA requires all students to pay a 50% down payment before beginning the enrollment into the program. The student will pay the remainder of the balance before the start of the 1st training session to meet the pay in full option.

Students have the option to do a 6-month payment plan. This plan is 10% more than the pay in full option. The chart below breaks down how all the fees and monetary credit options are calculated. Fees include tuition, books and materials, Drug tests, DOT physicals, and clearinghouse.

Students obtaining a valid permit before enrollment may be exempt from the \$158.00 course fee for CDL A Preparation. Additionally, those who successfully complete an online theory knowledge course from an approved vendor may be exempt from the \$200.00 course fee for CDL A Theory Knowledge. Successful completion and a passing grade will be granted to students meeting

these criteria. Services conducted externally, such as DOT Physicals and Clearinghouse, will be acknowledged, and associated fees will not be applicable upon enrollment.

## Payment Options:

- 6 Month Payment Plan
  - Payment Plan Fee = 10% of the program tuition
  - 6 payments due the first day of each month preceding enrollment in the plan for 6 months
  - Initial down payment will be 50% of the tuition, Books and Materials, DOT Physical Examination, 3-Year Motor Vehicle Record and the DOT Drug Test.
    - Total = \$2,339.50
  - Break down
    - 6-month Payment plan
      - 50% of Program Tuition cost without Credits = \$2,007.50
      - 10% Interest = \$200.75
      - Total cost with 6-month payment plan fee (excluding down payment) = \$2,208.25
      - Total Monthly payment plan fee per month for 6 months = \$368.04
- Pay in Full- Before any course begins
  - 50% of total program fees paid before enrollment into the program
  - Final 50% owed before the start of the 1st training session attended.

*CNS Driver Training Center of PA accepts 3 forms of payment, Credit card (Visa, MasterCard or Discover), Check and Cash. A receipt of payment will be provided at time of payment.*

## Graduation

The CDL Class A- Hot Shot Program requires 75 clock hours in a 4-week time frame to complete the program in a full-time enrollment status and a 5 week time frame to complete in a distance learning option. All graduates will receive a diploma.

*“Certain restrictions will be applied to a driver’s CDL at the conclusion of this program including L (airbrakes), E (manual restriction), and O (5th wheel restriction).”*

## Cancellation and Refund Policy

A 100% refund is provided if the student requests a cancellation within 5 calendar days after signing the enrollment agreement or, the student never began any of the training courses. Refunds are processed in 7-10 business days from the date of the approved refund. The approval of refund is determined by the school director or acting directors. Refunds do not include the fees for services already performed and materials already purchased, such as drug testing, MVR, and textbooks.

Refund Policy is based on the total clock hours of the program using the following percentages:

- (1) For a student completing up to and including 10% of the total clock hours, the school shall refund 90% of the total cost of the program.
- (2) For a student withdrawing from or discontinuing the program within the first 25% of the program, the tuition charges refunded by the school shall be at least 55% of the total cost of the program.
- (3) For a student withdrawing or discontinuing after 25% but within 50% of the program, the tuition charges refunded by the school shall be at least 30% of the total cost of the program.
- (4) For a student withdrawing or discontinuing after 50% of the program, the student is entitled to no refund.

## Job Placement and Student Services

CNS Driver Training Center of PA partners with their sister companies, Compliance Navigation Specialists Inc to provide access to their extensive job board for entry level drivers. Also, the entry level driver (ELD) will work directly with a driver specialist to complete their driver

qualification file and setup their FMCSA clearinghouse account to help better place them in a new career. CNS Occupational Medicine is onsite and has appointment time slots for entry level drivers to complete the DOT Physical and complete the appropriate submission for certification with the CNS Licensing Center. There is monthly CDL driver career fairs in which is accessible to all current and past trainees for job placement. Disclaimer, to obtain a job in the Hot Shot Trucking industry, a driver may have to own their own truck and obtain their own operating authority. **CNS does not guarantee any job upon completion of the CDL Class A- Hot Shot Program.**
